



Subsidized Child Care in New York State (Federal Fiscal Year 2014)

- \$794 million allocated to local districts for the NYSCCBG child care subsidy program in State Fiscal Year 2014-15.
- Approximately 217,000 children in 130,000 families received child care subsidies in FFY 2014 (annual).
- Approximately 130,000 children in 77,000 families received child care subsidies each month.
- Approximately 65 percent of children are from New York City.
- Approximately 48 percent of children received low income subsidies, while 52 percent of children with child care subsidies also received Temporary Assistance.
- Nearly 27,000 currently enrolled legally exempt providers.

Division of Child Care Services Miscellaneous Contracts

- 32 Child Care Resource & Referral Agencies for FFY 2014 - \$19.9 million (includes New York City with one lead and four subcontractors).
- Seven Infant/Toddler lead agencies for FFY 2014 - \$1.1 million.
- 38 Registration agencies in 2014 with a budget of \$18.5 million.
- Child care subsidy project memoranda of understanding (MOU) for income-eligible families: SUNY \$2.213 million; CUNY \$2.161 million; NYS Agriculture & Markets \$2.504 million;
- Unified Court Systems Children’s Centers \$150,000.

Advantage After School Program

- Approximately 15,000 children and youth served with a \$17.7 million appropriation (SFY 2014-15) and 111 contracts with 147 program sites.

Child Care Definitions:

- Day Care Centers (DCC) - provide care to an enrolled group of seven or more children at a facility other than a personal residence. Maximum capacity is driven by square footage allowance.
- Family Day Care Homes (FDC) - provide care to more than two non-relative children in a residence. Maximum capacity is eight children generally with one caregiver.
- Group Family Day Care Homes (GFDC) - provide care to more than two non-relative children in a residence. Maximum capacity is 16 children, generally with two caregivers.
- School Age Child Care (SACC) - provides child care to an enrolled group of seven or more children in a non-residence facility outside normal school hours. Maximum capacity is driven by square footage allowance.
- Legally Exempt Enrolled (LE) - providers of subsidized child care services, who are not required to be licensed or registered, but who meet minimum health and safety standards required for enrollment.
